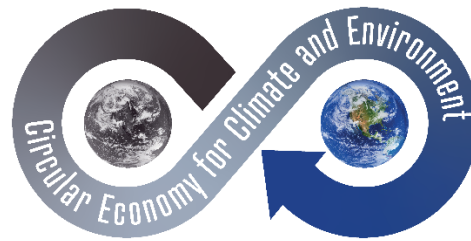

## **The conference**

The Circular Economy for Climate and Environment (CECE) is an annual international multi-disciplinary conference addressing the circular economy in a variety of sectors, including water, plastics, batteries, construction and fertilizers, underpinned by logistics, supply chains, governance, regulation and economics. Drivers of circular economies include energy, environment, waste management, resource recovery and climate change. The conference provides a platform for researchers, government, NGOs and industry practitioners to come together and share their work on the circular economy.

In its first two years (2023-24), the conference was held in Sydney. In 2025, CECE will be hosted for the first time in Melbourne.

The first two conferences saw many thought-provoking talks and workshops from leaders in their fields, including as examples Roch Cheroux (Managing Director, Sydney Water) and Lisa McLean (CEO, Circular Australia).

Sponsorship Terms and Conditions

The following terms and conditions apply to your application to sponsors:

1. DEFINITIONS

**Event** means the event referred to in the Booking Application.

**Us/We** refers to the conference organising committee.

**You** refers to the entity submitting the booking application form to sponsor and/or exhibit.

2. APPLICATION

You will submit the Booking Application Form to sponsor and/or exhibit.

3. APPROVAL AND PAYMENT

The sponsorship/exhibition will be confirmed upon return to you of the approved booking application form, together with a tax invoice for payment of a 50% booking fee. Payment of the 50% booking fee (non-refundable) is required to confirm your sponsorship/exhibition and is required 14 days after receipt of the invoice. Your company logo and profile will only feature on the conference website and any documentation once this deposit has been paid. The final payment of 50% is due 60 days prior to the commencement of conference. Failure to pay your sponsorship/exhibition invoice may result in your sponsorship item or exhibition stand being released for sale. All booking applications received within 30 days of the commencement of the Event must include full payment. International payments must include provision for bank fees and exchange rates in the payment amount.

4. CANCELLATION

The sponsorship/exhibition booking fee (50%) is non-refunded once payment is made and booking is confirmed. If You cancel your sponsorship/exhibition within 30 days of the commencement of the Event, You will not receive any refund from the final payment. If You cancel your sponsorship/exhibition before 30 days of the commencement of the start, You will receive full refund of the final 50% payment.

5. CHANGES

We reserve the right to amend existing unsold sponsorship packages or add additional sponsorship packages as required without notice to confirmed sponsors and exhibitors. We reserve the right to rearrange the floor plan and/or relocate any sponsorship or exhibition display without notice to You. The organising committee reserves the right to change the venue, dates or duration of the Event if circumstances demand. In the event of a change of venue, date or duration, the agreement to participate will remain in force as long as the sponsor/exhibitor is informed at least one month before the planned Event.
